LICENSE GRANT

- B. You may use one copy of the Software on one computer system. If the Software is transferred to additional computer systems, the Software must be deleted from the corresponding number of original systems.
- C. You may make one copy of the Software, in any machine readable or printed form, as a backup in support of your use of the Software.
- D. You may utilize the Software on a nonproduction computer system for up to thirty (30) days a year for testing purposes.
- E. You may not alter, modify, decompile, disassemble, or reverse-engineer any Software provided hereunder.

TERM

This license is effective until terminated. You may terminate it at any time by written notice to ASG and destroying the Software together with all copies. It will also terminate upon conditions set forth elsewhere in this Agreement or if you fail to make all payments due ASG in connection with the Software or fail to comply with any term or condition of this Agreement. You agree upon such termination to destroy the Software together with all copies.

PAYMENT AND MAINTENANCE TERMS

Any payments due under this Agreement shall be payable by you no later than thirty (30) days after receipt of an invoice. The annual cost of maintenance and support services is twenty percent (20%) of the then prevailing license fee at the time of maintenance renewal. Payment of the maintenance fee at the time of delivery of the Software and each year thereafter shall entitle you to maintenance and support services for the applicable maintenance period.

LIMITED WARRANTY

ASG warrants the media on which the Software is furnished to be free from defects in materials and workmanship under normal use for a period of ninety (90) days from the date of delivery. ASG's entire liability and your exclusive remedy shall be (a) the replacement of any media not meeting this "Limited Warranty" which is returned to ASG during the warranty period, or (b) if ASG is unable to deliver replacement media which is free of defects in materials or workmanship, you may terminate this Agreement by returning the Software and your money will be refunded.
